SECTION 1) A bill for an act. Be it enacted by the Student Senate:

An appropriation of no more than \$4,246 for the Co-Sponsorship of the 2009 Back to School Bash put on by the Student Activities Council (SAC). UH HSA will be covering the logistical costs of the event, including campus security, additional security, special-duty police officers, janitorial, entertainer transportation and hotel rooms for one entertainment group.

The Back to School Bash will provide the opportunity for all Chartered Student Organizations (CSO) to engage UHH students while providing a community experience on campus.

SECTION 2) The Senate authorizes the Executive Committee to research this appropriation. The Senate recommends the preparation and submission of a requisition for this appropriation by the Treasurer.
