SECTION 1) A bill for an act. Be it enacted by the Student Senate:

An appropriation of no more than \$500 for Hilo Ambassador La'akea Yoshida to attend the Phi Alpha Theta (National History Honor Society) 2010 Biennial conference, January 6-9 2010, in San Diego, CA. His paper titled "Bloodline Accession and Gifted Power: Nero Claudius Drusus and the Struggle to Define Heirship in Rome During the Reign of Tiberius" will be presented. He will also be attending the American History Association 2010 Annual Conference, January 7-10 2009, and will be the U.H. Hilo delegate at both conferences.

Per the Hilo Ambassador Funding Criteria:

- Funding shall allow coverage of: transportation, lodging, conference/event fees, a per diem for food and any costs incurred for a presentation, i.e. printing, materials, shipping, etc...
- All other funding criteria must be met.

SECTION 2) The Senate authorizes the Executive Committee to research this appropriation. The Senate recommends the preparation and submission of a requisition for this appropriation by the Treasurer.
